I. m/s/p Approval of Minutes of DA 4/23/13

II. Precinct Reports:

- A. Retired clerical workers are running office at John Adams on a volunteer basis.
- B. Other campuses, faculty is being asked to do one hour volunteer.
- C. Members are asking whether all faculty would get 2.85% increase as this year's retirees. Answer is no. Return of 2.85% just for retirees.
- D. Two new MOC people in precinct 11.
- E. Health Ed applications are down, but all regular part-timers are scheduled to teach.
- F. Dean of Students sent letter saying that in Fall 2014 CCSF would cut priority registration to various groups of students (those with too many credits, etc.)
- G. Counselors have been alerted to changes in common core & its effects, but few others are aware of these changes.
- H. Faculty doing outreach for Summer Session have had excellent response from the public.

III. Officer's Reports (President):

- A. AFT 2121 filed complaint with ACCIC. They are required to respond. It also goes to DOE.
- B. AB 1199 is still moving along, will be in Appropriations Committee next week.
- C. Board of Supervisors passed our resolution (as reported mid-meeting last month)

IV. Negotiations update:

- A. Unilateral annualized 4.4% wage cut implemented as of January 1, 2013. Amounted to 9.1% with back-wages. In 13/14 year, funding projection is \$151.6 mil from State, \$15.2 from Prop. A + other funds equalling \$198.8 mil. Previous high was \$199.6 (10/11 year). Now we have fewer full time faculty, part-time faculty, benefitted faculty.
- B. We are invoking the trombone clause to demand that District bargain with us over new funds coming in.
- C. We are working on constructing an alternative budget, though effort has been hampered by inaccurate & incomplete information from district.
- D. We are demanding return of 5% cut by putting smaller amounts toward reserves, lawyers, etc.
- E. Cost of restoring 5% cut would be \$5 mil.
- F. ULPs is on hold with Public Employees Relations Board until we have finished arbitration over the our grievance. If arbitration is not successful, we can re-file ULP.

 - re-democratize education
 - There are some areas that require deeper dialog.
 - Living wage for student workers. Raise to city minimum wage.
 - Form an Educational Justice Committee within 2121.
