COPE (committee on political education) account

Within CFT, AFT, local COPE accounts can be used for local and state races (money given directly to candidates).

<u>Process I.</u> PIPE (partners in political education)AFT's federal PAC campaigns. Cannot be from dues, only from voluntary contributions. Process:

2121 COPE \$5000 → \$5000 PAC check to AFT National COPE account → AFT National writes \$5000 dues check to 2121 General Fund (not PAC)

<u>Process II.</u> Through change in bylaws or resolution, a local can decide to transfer \$x/member/month from general account to PAC account:

2121 General fund → 2121 PAC account
