- 1. Call to Order
- 2. M/S/P of Agenda and Minutes of 3/3/2015
- 3. Check-ins
- 4. Introduction: Michael McCown (Tim)

  Our new full time paid organizer will be working on our contract campaign. Today is his birthday.
- 5. Negotiations Organizing (Tim)
  - a. Tomorrow: 4/8 pre-negs the district will present on budget. We need clear budget info, which they have not yet provided. Gerhard is working on it. He will focus on the fiscal cliff if enrollment doesn't recover after 2 years. We want to focus on the growing fund balance that reached 12.9% as of last June 30<sup>th</sup>. This is way above the state recommendation. It leads to an argument about the 8 year stability plan. Percent = reserves/total expenses. They are following the 8 year plan as a formula. They are well above even their own stated range. The 8 year plan is a plan for downsized faculty and downsized salaries.
  - b. Board sunshining public comment will be this Thursday MUB 170 5:00 pm. You can write to Linda Shaw and get on the list for notification of board meetings.
  - c. Informational picket at first official negotiations session will be 2-3 on 4/15 pushing for open negotiations and including enrollment at the negotiating table.
  - d. Lillian Marrujo-Duck has put forward two resolutions to Academic Senate in support of open negotiations and for having enrollment at the table.
- 6. Contract Action Team (Alan)
  - We phone banked our Contract Action Team list (108 people) we have 17 people confirmed coming for an informational picket 2-3 Wellness 103 on 4/15. We will inform pct. reps. We will send info about contract action events to Joe so he can send it to the retiree members.
- 7. CFT Convention report back (Tim/Alan/Alisa)
  Kudos to Alan D'souza for organizing all the details. Our Compton resolution was very successful and timely. Our PT faculty resolution was also well-received. Alisa Messer won the woman of the year award. Great delegation, powerful presentation by Jeff Andrade from SF State. He talks about the issues that impact our communities violence, poverty,



- etc. Janey, Li and Doug were honored as well, and we won 5 communications awards including best email newsletter. Those who attended need to submit expenses.
- 8. Families for an Affordable SF fall campaign (this was our first time doing a major independent expenditure campaign) report back. We lost the election, but are analyzing what happened. We actually did very well at turning people out and raising the percentages for Campos. Majority of voters are vote by mail now and we need to adjust to that new reality. These efforts may need to happen earlier. Looking to the future district 3 election next fall: Aaron Peskin, Christianson (appointed by Lee). Labor council has decided not to take a position. Also Mar, Campos (Hilary Ronin, Edwin Lindo, Josh Arce), Avalos all termed out. District 11 Asha Safai, Kimberly Alvarenga.

## 9. Items needing attention:

- a. People getting terminated without people even getting the basic protections of the contract
- b. Hiring/upgrading grievances no evidence for why they hired certain people another area where things have been rolled back
- c. CALStrs district did not make the necessary change in reporting non-credit service credit. So people have less credit than they should have. Cliff has identified who it applies to. This includes some people who have already retired. We filed a demand letter. This is a big deal.
- d. Sick pay remains a real problem they have possibly overdeducted from possibly a lot of people.

## 10. Legislation (Tim/Alisa)

- a. Sacramento CFT Lobby Day April 20, 21
- b. Board of Supervisors May 7 Supe Mar is holding a hearing with an update on CVC campus Campos, Christianson, Jane Kim will sit in. This is asking for a general update on CCSF. The district is working on the lease for the CVC replacement building. The Central City Coalition for Public Education met with Fred Sturner. They got a call today following up to say that they've negotiated but not yet signed the lease. He's committing to community outreach. The lease will be for 6-years. Our pressure on the situation has helped with resolving this in a slightly more positive way. The hearing is a point of pressure as well. \$38/square foot. Its .75 mil per year.
- c. CFT-sponsored bill on accreditation reform
- d. AB 404(Chiu) –Accrediting Agency Accountability (already approved to endorse via email vote) he had a good op-ed in examiner yesterday. The bill passed out of assembly higher-ed committee today.
- e. Ting has two bills in process relating to Accreditation— these will go forward the week after lobby day.
