 - Bargaining team met for a 3-hour strategy planning session this Saturday. We face a tough fight on our contract campaign. Our platform is based on the theme of Rebuilding our College. Our main struggle is that we face the loss of stabilization funding from the state in '17-18. This would be a \$38 M drop.

They have been open to talking with key people who understand the issues to try to make the best possible case going forward with reconsideration.
