5. Contract Negotiations
 - a. Bringing in Community support – we should invite the Free City community and our other allies. Key questions facing the college: how are they going to rebuild the college? Will they continue with their plans to make further cuts? We don't think that model will work. It's a recipe for not meeting community needs. FT faculty core has been decimated. Changing that will bring job opportunities to the community and bolster the college. Another community issue is our calendar.
 - b. Listening Sessions update 210 surveys have been returned. Listening sessions are going really well as we reach out and connect with people. Bargaining team members are stepping up and attending the meetings at different campuses.
 - c. The district has proposed a joint sunshine at a special BOT meeting on 10/12 with public comment on 10/26. This means our sunshine proposal will need to go to the DA on 9/26.
6. Oakley letter about AFT 2121 to college presidents. The state chancellor of community colleges wrote a letter to all of the CEO's of the colleges after the CFT lawsuit against ACCJC has been settled. This is the 3rd time in his tenure that he has singled out our college: The 35M audit, the letter about the PAEC, and now an attack on our union for suing the ACCJC and the State Chancellors' office/BOG. CFT will read a letter in response at the BOG meeting. We are going to refrain from responding as an organization. Instead we will respond along with the college.
7. Appointments to Union Finance/Budget Committee.

8. Balboa Reservoir Discussion

If the Mayor goes through with his plans, it's going to adversely affect the college and our enrollment. They haven't responded to my information request yet.

We may also want to make a PIR to the State Chancellors' office on a broad scope about the PAEC. AJ already did one to the city/PUC.

Save CCSF coalition is looking at this seriously now, and there is now more momentum.

They've chosen the one with 1100 units, though they promised it would have only 500.

Rizzo has a resolution asking the Chancellor to approach the PUC requesting that they be allowed to purchase the land.

We want to make sure that whatever happens is student-centered. Alan is an alternate on the facilities committee, and will work to represent our interests.

9. DACA response: we will put out a response to our members with a basic explanation of what D. Trump has done, and that we are educators and teachers and we will stand up for our students. Also a list of actions. What about setting up a rapid response system.
