Asked for support for their boycott of concession stands at ATT Park to pressure mgt. to negotiate in good faith.

- 7) Contract violations, failure to bargain, pay/sick pay grievances
- a. Schedule deviations (FT overloads/underloads); District threatening to make retiring faculty pay back for owed units.
 - c. Counselor restructuring without input from counselors
- d. Sick leave: one worker had 170 days rather than 170 hours of sick leave subtracted from his account. Web4 payroll interface doesn't show accumulated sick leave in violation of contract.

Recourse: mass grievance

Inform members: FT should earn 5 days (25 hours)/ semester, 10/year (=50 hours) prorated for reduced load.

File mass grievance for violation of contract demanding restoration of Web 4 pay advice PDF document on grounds that many faculty don't know how to access new form, change made without consult, and express provision of contract (Art. 17.C.5).
