# Minutes - AFT 2121R General Membership Meeting March 11, 2021 2:29 - 4:43 PM

Present: Susana Atwood, Joe Berry, Ron Bixler, Guy De Primo, Allan Fisher, Ann Killebrew, Doug Orr, Leslie Smith, Debra Wilensky, Sally Winn

- I. Agenda:
  - The agenda was adopted unanimously.
- II. Minutes for February 11, 2021:
  - The minutes were revised.
  - The revised minutes were approved unanimously.

#### III. Check-In

- Leslie Smith CFO John Al-Amin reported at the Board of Trustees Budget and Audit Committee that CCSF has received an extension to report on how it will/has spent Federal dollars related to COVID.
- Joe Berry his book, Power Despite Precarity, will be published by Pluto Press in June.
- IV. Guest presenter: Leslie Smith was invited to discuss the CCSF Virtual Retirees.

  There was a wide-ranging discussion of who the CCSF Virtual Retirees are, what the CCSF Virtual Retirees are doing, and on the central issue of the moment, the budget crisis.
  - All are welcome at CCSF Virtual Retiree meetings.
  - The one officer for the CCSF Virtual Retirees is its Secretary, Jane Sneed.
  - O Doug Orr shared with us the CCSF Virtual Retirees Mission Statement. [See first attachment.] Leslie Smith noted that the group's goal is to support City College. Their focus is on unity in support of the college; right now the focus is on the budget cuts.
  - Guy De Primo shared with us Article III. of our AFT 2121R Bylaws on our Objectives, so we could see the overlap.
  - The CCSF Virtual Retirees agreed on promoting the AFT 2121 Retiree Chapter.
  - Next month's meeting will discuss communication; the current proposal is a newsletter with links, and then a "sidebar" for those wishing to participate at a deeper level on issues.
  - They keep minutes brief, to protect members employed by the college from retaliation.
  - The Academic Senate, at its meeting yesterday, passed a resolution that details all of the education code violations that are occurring in conjunction with these layoffs. [See second attachment.]
  - The CCSF Virtual Retirees think a three-pronged strategy for opposing the budget cuts could work:
    - Use a Temporary Restraining Order (TRO) based on the Academic Senate
       Resolution documenting education code violations. Filing a TRO stops the whole
       process immediately, and holds until it goes to court. Bezemek could do it.

- Get the Labor Council and every single labor organization in San Francisco to tell the Board that if they vote at the April Board meeting for layoffs, they will never get a labor endorsement again.
- For City College, fix the registration system, fix the marketing, and improve the admissions website and help to grow the college.
- Leslie Smith offered the following political insights:
  - San Francisco has a gigantic budget problem.
  - SFCCD, a state/local agency, is not part of the City and County of an Francisco. SFCCD should be looking for assistance at the state level.
  - AFT 2121 should meet with Phil Ting, Chair of the Assembly Budget Committee, and with Governor Newsom.
  - FACCC, if approached, would be willing to help.
  - We need to gather local and state political support and go to the legislature, to let them know that we are being destroyed by our local administration and Board of Trustees.
  - O The press is beginning to see it. We need to talk in the press about the reduction in educational access and the impacts on students, the negative impact on intergenerational poverty, the anti-immigrant aspects ESL has dropped from 25,000 to 4,000 students, the loss of the disabled students program, and the cancellation of 90% of the older-adult program when classes were 100% full.
- Leslie Smith reported that the direction at the state level is the opposite of what is happening at City College:
  - The community colleges are getting growth money this year.
  - In Assembly and Senate committee discussions on community colleges, everyone is focused on life-long learning and job reemployment. Transfer is not being discussed.
  - On the CCC Chancellor's Office website, life-long learning is right there next to transfer.
- Joe Berry will inquire about Phil Ting with and pass on the Temporary Restraining Order suggestion to the AFT 2121 Executive Board.
- Ann Killebrew noted that she was surprised by the lack of broadcasting by AFT 2121 to other groups about the situation at the college.
- Doug Orr stated that our situation has been communicated to the leadership of CFT, and they have been talking quietly to people around the state.
- Ann reported that, this week, Jeff Freitas wrote her that he has had to pull back; he has offered CFT help and AFT 2121 has not said yes, we need your help.
- O Joe Berry noted that with everything going on, this is a difficult, stressful time. It is really important that people talk to each other in a way that does not assume bad faith. All of us have been guilty of that, in tone, in content, by omission, by commission. It will kill our joint struggle if we don't clean that up. That means a substantial number of people having to swallow their tongues if we are going to generate the struggle necessary, which will have to be on the level of the struggle against the ACCJC.

- V. Financial Literacy and Retirement Planning Virtual Workshop Sharing:
  - A. How might our workshops template with instructions be shared with other locals? Doug Orr reported that the CFT Retirement Issues Committee will host four virtual Convention workshops.

B. CFT is interested in a convention workshop run by us to discuss our Financial Literacy workshops.

Ann Killebrew reported that convention workshop organizers have not followed up on having a workshop presentation on our Financial Planning Day.

## VI. AFT 2121 Updates:

A. AFT 2121 Delegate Assembly Meeting:

Doug Orr reported on the AFT 2121 Delegate Assembly of February 16, 2021. Discussion and actions included:

- There was a lengthy battle over the agenda.
- There was a good discussion, time-restrained, on bargaining campaign planning how to build power for a bargaining campaign.
- There was a discussion, time-constrained, on the Vote of No Confidence resolution regarding Vurdien, Gonzales, and Boegel. No vote was taken.
- Susana Atwood noted that support for passing the Vote of No Confidence now, as opposed to later in the bargaining campaign, appeared to be about 50-50. It is on the agenda for the March 23, 2021 General Membership Meeting.

## AFT 2121 COPE Meeting:

No report.

### B. AFT 2121 Executive Board Meeting:

Joe Berry's reported on the March 9, 2021 AFT 2121 Executive Board meeting. [See third attachment.]

- Retiree dues: In 7 months AFT received \$2,295; only \$875 had been budgeted.
- How we retirees might help with internal organizing should be figured out soon.
- FT layoff appeals and bargaining strategy, were discussed in closed session.
- The Executive Board called all the Full-timers who got layoff letters to connect, to encourage them to come to the March 12 demonstration at City Hall, and to encourage them to post individual videos on the impact of the cuts on our AFT 2121 YouTube site.
- AFT 2121 is encouraging people to appeal their layoff letters. There will be a mass hearing as mandated by education code. Bezemek will be questioning people and challenging the layoff letters on as many different bases as we can.

- O Joe explained that if all of these layoffs were to go through, it would mean that over half of the current CCSF faculty would be out as the vast majority of part-time faculty would be laid off too. An even higher percentage of people of color would be out.
- O Joe noted that no district has ever implemented all March 15 letters; the next deadline is May 15, and then the real deadline is do they rescind any layoffs before school starts.
- C. Pink Slips and Demonstration Friday, March 12.
  - The physical demonstration is at noon at City Hall. Physical bodies have much more impact; demonstrators on Zoom are much easier to ignore.
  - The virtual press conference is 11:30 1 by Zoom.

#### D. Other:

• Affirmative Action Task Force
The Task Force is looking into how the cuts will affect affirmative action.

# VII. CFT Legislative Committee report:

Ann Killebrew and Doug Orr attended the March 9 meeting.

- O Doug Orr said that the knowledgeable CFT staff lead a discussion of 38 pages of CFT-sponsored bills and bills of possible interest. Decisions were made on which bills to support, support if amended, watch, or oppose.
- Ann Killebrew observed that the meeting was well organized. She would like to see more bills that apply to Black Lives Matter issues, especially police education.
- Doug Orr reported that the packet included AB17 on police hiring, AB26 on police excessive force, and AB89 on police educational requirements.

## VIII. California Alliance for Retired Americans (CARA) Update:

## A. Meeting Report

- Two weeks ago, Tina Martin sent out the report on the February 11 CARA meeting in San Francisco.
- Tina Martin is attending today's CARA meeting in San Francisco.
- B. Payment of our \$50 CARA membership dues were approved at the February 11, 2021 AFT2121R General Membership Meeting.
  - Ann has submitted the payment request to Wendy Leung.

# IX. CCSF Participatory Governance Committee, Budget Committee:

Susana Atwood's report engendered a wide-ranging discussion.

- O Susana reported that a selective list of the expenses that are causing our budget crisis, presented by CCSF Chief Financial Officer, John Al-Amin, begins with the Retiree Health Contribution of \$10,800,000. So the big piece of his \$27,000,000 list is attacking retirees. Administration is trying to pit full-timers against retirees.
- The March 10, 2021 CCSF Press Release includes this same list.

- In the Press Release, the administration says, and we agree, that the current legislative funding model for community colleges must change. We need to put pressure on the legislature to properly fund education.
- There was agreement that our first need is to grow the college. There needs to be an effective campaign to increase enrollment.
- Leslie Smith inquired how utilities, which John Al-Amin claims have increased by \$1,000,000, could go up during COVID. Susana Atwood explained that it had to do with the utilities billing CCSF late and with some legal reason why CCSF was not allowed to shut off utilities during COVID.
- Oug Orr stated that the Press Release is trying to make it look like the only thing to do is cut salaries; it is an anti-labor, union-busting process from the administration.
- Leslie Smith reported that the legislature might raise this year's COLA.
- Leslie noted that the last K-14 funding proposition failed in November. There is some support for a wealth tax proposition.
- Leslie explained that federal stimulus money is one-time with strings; for past stimulus money, the administration has had department chairs submit plans for its use and presented a proposal to the Board. The new stimulus money will be handled similarly.
- Ron Bixler suggested that we use the stimulus money to launch an enrollment campaign.
   Susana Atwood reported that Chancellor Vurdien and Chief Financial Officer John Al-Amin, believe that such a use of stimulus funds is prohibited.
- O Joe Berry noted that the district has refused to project any plans for the Fall. Doug Orr stated that this is consistent with the past several years. Doug believes that Tom Boegel is shrinking CCSF to a 30,000 student, transfer-centered institution.
- Doug Orr suggested that we use the stimulus money to fix the online registration system.

# X. Treasurer's Report:

- Over the period July 1, 2020 January 31, 2021, Retiree Chapter dues revenue was projected to be \$875. Actual dues revenue was \$2,295.
- Susana Atwood reported that she has sent in the paperwork for the reimbursements approved for her this past few months. Payment has not yet been received.
- Guy De Primo is to send Susana Atwood a copy of the approved minutes for each meeting.

#### XI. Reimbursements

- A. Yvonne wrote instructions for completing the AFT 2121 donation or reimbursement form to be mailed to Wendy Leung.
- B. Ann Killebrew sent a copy to Susana Atwood to use, and completed a form for the CARA dues.

#### C. Other

Motion by Ron Bixler, seconded by Doug Orr, to reimburse Susana Atwood a total of \$109.96 for the following Retiree Chapter Zoom account expenditures: \$14.99 per month for the four months January - April, 2021 and the \$50 large meeting charge for the January Financial Planning Day.

### XII. CFT Committee Meetings and the CFT Convention

#### A. CFT Retiree Issues Committee:

- The AFT 2121 resolution on the social security windfall elimination provision and the government pension offset is in the list of resolutions for the convention. It should pass, for the third time.
- Doug Orr encouraged people to attend the Ceres 2021 Conference from March 22-25. Ceres offers businesses and investors initiatives around dealing with climate change and the transition to net-zero carbon emissions. Go to www.ceres.org for more information.
- O Doug noted that for at least 3 years, CalSTRS has been pushing for corporations to report their carbon footprints in their annual reports. In the last two weeks, the SEC has taken up this issue and will vote on it soon. Additionally, the Federal Reserve Board has taken the position that carbon footprint reports should be required for corporations.
- Leslie Smith noted that the 2021 Federal Infrastructure Bill has a solid chance of passing. It would be the largest labor bill coming out of Congress in decades. It will be closely connected with the green movement.
- Leslie Smith stated that labor and climate are absolutely linked.

#### B. CFT Labor and Climate Justice Education Committee

• Ann Killebrew reported that the committee is thinking about whether to offer any convention workshops. A final decision will be made next week.

## **Approved Resolution Effects of Programmatic Reductions**

**Whereas,** California Code of Education 78106 (a) states, in part, that "Every vocational or occupational training program offered by a community college district shall be reviewed every two years by the governing board of the district;"

**Whereas**, California Code of Regulations Title 5, Section 51022 states, in part, that "(T)he governing board shall adopt and carry out its policies for the establishment, modification, or discontinuance of courses or programs;"

**Whereas,** California Code of Regulations Title 5, Section 55130 states, in part, that "(T)he development, establishment, and evaluation of approved educational programs included representative faculty involvement;"

**Whereas,** the Accrediting Commission for Community and Junior College Accreditation Standard II.A.15 states "When programs are eliminated or program requirements are significantly changed, the institution makes appropriate arrangements so that enrolled students may complete their education in a timely manner with a minimum of disruption;"

**Whereas,** Board Policy 6.17 City College of San Francisco Program Revitalization, Suspension, and/or Discontinuance states, in part, that "Program suspension can be recommended only at the conclusion of an established collaborative process that analyzes appropriate data and applies established criteria. The plan must include provisions for students already enrolled to complete their education in a timely manner with a minimum of disruption;"

**Whereas,** Administrative Procedure 6.17, City College of San Francisco Program Revitalization, Suspension, and/or Discontinuance states, in part, that the PRSD procedure may only be suspended on an emergency basis if "The appropriate dean(s), the appropriate department chair(s), and a majority of the faculty in the department support the suspension or discontinuance of the program;"

**Whereas**, the actions of the Board of Trustees on November 14, 2019 in suddenly cancelling 350 sections and laying off part-time faculty effectively resulted in the effective loss of (number) Noncredit and Credit Certificates without following the PRSD process;

**Whereas,** the actions of the Board of Trustees on February 25, 2021 in agreeing to potentially lay off 163 full-time faculty as well as all part-time faculty effectively will result in the effective loss of (number) Noncredit and Credit Certificates without following the PRSD process;

**Be it Resolved**, that the Academic Senate is of the opinion that the CCSF Board of Trustees and Administration are out of compliance with California Code of Education, California Code of Regulations, Accreditation Standards and its own policies.

**Be it Further Resolved**, that the Academic Senate requests that the CCSF Board of Trustees and Administration bring the College back into compliance by instituting appropriate PRSD procedures for all programs impacted by the above mentioned Board actions.
