VI. Oral History Project (OHP) - Bill Shields.

- A workgroup met at the union office on Friday, November 22.
- The OHP committee met on Tuesday Dec 7 and moved our work forward.
- The OHP is on recess until after Financial Planning Day.
- The workgroup research is getting pretty close to the end of the 1970s.
- Some 50th Anniversary posts, written by Guy De Primo, have been sent to AFT 2121 for their consideration. Others are invited to write posts.
- Guy De Primo will forward the posts to Susana Atwood, Doug Orr, and Debbie Wilensky.
- After Financial Planning Day, OHP workgroup sessions at the union office will resume, and we will seek more coordination with the 50th Anniversary Committee.
- Bill Shields is in touch with Jane Hundertmark, regarding the 700 word article about the Oral History Project. We have pictures taken at the union office with Malaika.
- Bill Shields will be speaking about the Oral History Project at lunch time at Financial Planning Day, inviting people to participate.
- In early 2022, we hope to begin interviewer training. That includes formulating a series of questions, and choosing appropriate technology. Then we will begin interviewing.
- The interviews will be housed at the SFSU Labor Archives, and we can use our work for a 50th Anniversary panel presentation and other things such as for a storytelling presentation.

VII. AFT 2121 Reports

A. Delegate Assembly - Doug Orr.

- Met: Tuesday, December 14, 2021.
- 98% of the faculty are now vaccinated.
- The return to work negotiations with the District are ongoing.
- Chancellor Martin says he is going to send out pink slips.
- The Administration has basically not shown up to the last two salary cut restoration bargaining sessions. It has become obvious that the administration has no intention of restoring any of the salary cuts.
- The strategy for building power in preparation for the next negotiations, was discussed. Our usual methods, such as rallies and sitting in at Board of Trustees' meetings, have been taken away from us by COVID.
- The effort of the Coalition of Labor Organizations to get the City to allocate ongoing funding to supplement the budget of City College, was reported.

B. COPE - Doug Orr.

- Met: Tuesday, December 14, 2021.
- Money was allocated to the David Campos for Assembly campaign.
- Phone banking for the Campos campaign was discussed...
- There will be a lot of political campaigns next year seeking our endorsement and support.

- C. Executive Board No report.
 - Met: Dec 7, 2021.
 - The Board put out an advertisement congratulating the CCSF RAMS Football Team for their state and national championships.

D. Other

- Putting another initiative on the 2022 city ballot to allocate money to CCSF is under consideration. This initiative would be worded to require that the money go to CCSF and hence not require action by the Board of Supervisors. It thus will require a 2/3's vote for approval.
- Claire Heimer has replaced Doug Orr in meetings with the Chancellor and presentations to the Board of Trustees. It is a better look to have an active faculty member in this role.

VIII. CCSF Reports

- A. CCSF-PGC Budget Committee Susana Atwood.
 - Met: November 23, 2021.
 - John Al-Amin did not post a spreadsheet in advance, only shared part of a spreadsheet on screen at the meeting, and would not provide copies. He said it was incomplete.
 - John Al-Amin's interrupted Simon Hanson so rudely that Simon left the meeting.
 - An SEIU representative moved that the meeting be adjourned because it was too hostile. Susana Atwood seconded. The meeting was adjourned.
 - When John Al-Amin presented the spreadsheet to the Board, his projection for the last 8 months of this current fiscal year were not done month by month, so it was hard to tell why the spreadsheet now shows us going way over budget.
 - We have been told that John Al-Amin has since apologized to Simon Hanson.

B. Other

• Attorneys - Ann Killebrew posed for discussion whether AFT 2121 could/should file lawsuits regarding some of the actions of CCSF administrators. The majority felt that their actions do not rise to that level.

- A. Community College Council (CCC) Report skipped for lack of time.

- B. Council of Retired Members (CRM) Report skipped for lack of time.
 - Met: December 3, 2021.

- C. Retirement Policy Committee (RPC) Doug Orr and Ann Killebrew
 - Met: December 4, 2021.
 - A resolution put forward by the Climate Change Committee, calling for CalPERS and CalSTRS to divest from fossil fuel companies and any commercial industries that are significantly contributing to climate change, was passed at the 2016 CFT Convention.
 - We are the only union to have a resolution that goes so far.
 - Satisfying the resolution would require CalPERS and CalSTRS to divest from most of the economy, so is unworkable for them and makes us look like idiots.
 - Until now, Doug Orr had been using a section of the resolution that said until they divest, we encourage them to engage, to push engagement.
 - The Climate Change Committee is demanding that Doug Orr push at CalPERS and CalSTRS to divest.
 - If it comes to it, Doug Orr will resign as chair of the Retirement Policy Committee rather than do this.
 - The idea of putting forward a new resolution to address the situation, was discussed.
