9. Resolution in support of Philippine Human Rights Act

Resolution was drafted by Eugene Gambol in conjunction with students, former students, and colleagues to bring attention to current political/social situation in the Philippines. Labor Council and other labor and community organizations have endorsed the Philippine Human Rights Act to demand an end to US military aid to the Philippines until human rights abuses are stopped.
Guest and former CCSF student Brandon Lee spoke about his experiences as part of a resistance movement, lending a voice to the oppressed in the Philippines. Jeff Stanley, current CCSF student, explained more about the context for the proposal.

Draft resolution will be revised based on feedback and brought back to DA for endorsement vote next semester.
