The timeline and other information about the hearings and layoff process is on the AFT 2121 website. The legal scope of the hearings is very narrow, and the judge will be considering individual errors, not large scale issues that affect the bargaining unit and the college. Based on administrator testimony in the hearings, it is clear that the district plans to break the law (ed code) by laying off full time faculty and hiring them back as part time.

 Latest updates are on the AFT 2121 website. The Bargaining Team has identified many
 errors in the district's budget assumptions; multiple open bargaining sessions to be
 scheduled next week.
- 8. Organizing to win
 AFT organizers discussed: budget education campaign, lobbying campaign, media
 campaign. Followed by a phone call action to Supervisors Walton and Haney's offices to
 support supplemental funding to college.
- 9. Affirmative Action Task Force update from Rhea Dellimore: working on securing funding to support AATF initiatives from the city's Human Rights Commission; the college has given permission to seek private funding that will be applied to the African American Studies Department and new Research Institute.

- b. Sue Englander announced that the Harvey Milk Club has endorsed a resolution protesting the cuts, and has published it in their newsletter.

- d. Malaika gave an update on the previous day's press conference hosted by DSPS and OLAD, highlighting cuts to the part time faculty in those departments.
- e. Harry Bernstein reported on a bill introduced in the US Senate about repealing the government pension offset and windfall elimination provisions.
