1. Call to Order
2. Meeting process and agreements discussed.

4. Officers’ Reports Report from President Malaika Finkelstein. Report from Treasurer Yvonne Whitelaw. Report from Secretary Dayna Holz.
5. Report back from COPE – election response Update on coordinating nonviolent post-presidential-election resistance efforts among labor and community organizations, in anticipation of potential election coup.
6. Organizing team report Christina Yanuaria presented on upcoming series of member events: Organizing for Humanity.
7. Precinct Rep election results Election Commissioner Kathleen Duffy reported that technical issues of running 40 separate remote elections have caused delays in reporting results. Election Commission will report results shortly.
8. Return to Campus update Tehmina Khan, Audrey Wallace, and Robin Pugh have been working with a group of faculty reviewing safety plans for departments intending to offer in person classes or services. Developing rubric for affected faculty to use as a way to review plans for their own department. Return to Campus proposals and rubric will be available on AFT website.
9. Update on Evans and Airport Evans faculty reported on status of lease at Airport Campus, proposed relocation of aeronautics program to Evans, displacement of existing Evans programs, environmental impact of running airplane engines in a neighborhood. Organizing efforts have involved faculty, students, community organizations, and city leaders.
10. Impacts Bargaining update

Recent negotiations have addressed evaluations and how to reflect the crisis-situation work happening during a pandemic. Until an agreement has been reached, evaluations are on hold, despite contradictory information from administration.

11. November election prep

Discussion and training on mobilizing for the November election for issues and candidates which will have an impact on public education and CCSF funding. Major efforts including phone banks and lit drops are being organized around Proposition 15/Schools and Communities First, Proposition 16/Reinstating Affirmative Action, and the Biden/Harris campaign.

12. Retiree Chapter resolution on Black Lives Matter

AFT 2121's Retiree Chapter has passed a resolution on BLM and has asked the entire AFT 2121 local to endorse the resolution.

**m/s/p Endorse the resolution as written and then further create our own version.**

The Affirmative Action Task Force was asked to edit/create/work on a new version and bring that to a future Delegate Assembly.
