# ARTICLE 28 RETIRED FACULTY RE-EMPLOYED AS FACULTY

# 28.A. Retired faculty Re-Employed as Faculty

- 1. Retired faculty who receive assignments are working as part-time, temporary faculty.
- 2. Retired faculty wo receive such assignments are not eligible for re-employment rights preference or modal load.
- 3. [Pay for retired faculty: Needs clarification. Defer until later in negotiations process. when we discuss compensation.]
- 4. Applicable provisions for Retired Faculty Re-employed as Faculty

The following terms and conditions of the Agreement are applicable to faculty retired from the District who are subsequently re-employed as temporary, part-time faculty.

### B. Access to District Facilities for All Retired Faculty

# 1. Access to District Email and Individual Websites for Retired Faculty

For the life of this Agreement, faculty who retire may continue to use their District e-mail accounts subject to the conditions and limitations applicable to active employees. The District acknowledges the potential value of retired faculty members' ongoing involvement in the District educational process, including non-commercial contributions to the District intranet and District web site. Faculty who wish to maintain their individual City College supported web sites can request to continue their access by application to their dean subject to approval of the appropriate vice chancellor.

# 2. Access to Parking Permits, ID Cards

Retired faculty shall be eligible to receive replacement CCSF ID cards and parking permits for the Ocean Avenue Campus.

#### 3. Access to District Facilities

Retired faculty shall have the same access as currently employed faculty to the pool, wellness center, and District libraries.
